**RECEIPT – PIT VEHICLE RULES AND REGULATIONS**

1. **No one under the age of 18 may operate a pit vehicle.**
2. No passengers are permitted on motorbikes or scooters.
3. Helmets must be worn on motorbikes and scooters.
4. Pit vehicles cannot be operated in a negligent, reckless, careless or dangerous manner.
5. Pit vehicles must be operated at a reasonable and safe speed and will not exceed 5 mph.
6. Pit vehicles may only be operated between the hours of 6:30 am and 8:30 pm.
7. Pit vehicles are not permitted in spectator areas, in woods, or in any area in the back of the facility.
8. That no trail riding is permitted.
9. Pit vehicles are to be used as a means of transport, not as a means of recreation.
10. That I nor my passengers will not consume or have consumed any alcohol before or during operating my pit vehicle.
11. That breaking any of the above rules will be grounds for my pit vehicle to be confiscated and/or my permit to be revoked.
